T1.1 TENDER NOTICE AND INVITATION TO TENDER

- Sealed Tender offers are invited for the provision of luncheon services (canteen services) to Botswana vaccine institute limited (BVI) staff for a period of two (2) years.
- The Procuring Entity is Botswana Vaccine Institute Limited.
- Procurement Method is: Open Domestic Bidding
- Tenderers who are domiciled in Botswana must, in order to be considered for the award of the contract, be registered with the **Public Procurement Regulatory Authority** in the following categories:

- Preference margins will be applied to qualifying bidders in line with the prescribed
  Preference Scheme
- Economic Diversification Drive (EDD) or
- Local Procurement Scheme (LPS) (Only one will apply which benefits the Citizen more).
